### AKC Scent Work – Handler Discrimination, Parts 1 and 2

Who can attend? Any dog, whether or not he/she has any scent work experience.

What's the cost? \$120 for both dates (must attend both dates to learn the material). Limit 6 working Teams.

Can I audit? No, sorry, for this type of seminar auditing will not be helpful to learn the material, it's a hands on seminar!

What's the schedule? 1/31/26, 8:30AM – 12 PM / 2/14/26, 8:30AM – 12 PM. Each seminar will be followed by scent work run throughs from 1-4pm, interior and container searches at Novice, Advanced, and Excellent levels.

Can I work a second dog? Yes! If you want to take this seminar with a second dog, the fee for the second dog is \$100 for the seminar.

Are cancellations allowed? For cancellations more than 2 weeks prior to the workshop, before 1/16/26 full refund is available. For cancellations less than 2 weeks prior to the workshop, no fees will be refunded unless we can fill your spot. Bitches in season and aggressive dogs are not allowed on the grounds. If you plan to attend with an intact bitch, you should plan ahead and arrange to have an alternate dog of similar skill level available to work. No refunds for bitches in season unless you cancel before 1/16/26.

## **AKC Scent Work Handler Discrimination Seminar Description:**

Handler Discrimination, unlike other classes in AKC Scent Work, needs specific training for the handler and dog team to be able to understand what's required and to ultimately qualify. In this seminar, you will learn how to teach your dog to recognize and alert on your odor, and you will be given your own HD box to practice with between the two parts of the seminar (yep, there's homework!)

### ***REBECCA CASH & Team Little Dog***



Rebecca taught herself and homeschooled Team Little Dog, as well as trained under AgileDogs' former instructor, Laura Clute, who is now semi-retired in Florida. All 3 of Rebecca's dogs have Novice and Advanced Handler Discrimination titles with impressive placements, and they will be competing in the Excellent division this year.

Rebecca has competed in Handler Discrimination 26 times with 3 different dogs. Team Little Dog Q'd 24 of 26 times! In Novice, they placed 11 out of 12 times and took four 1sts, four 2nds, two 3rds, and a 4<sup>th</sup>. In Advanced, they placed 8 out of 14 times with a 1<sup>st</sup>, three 2nds, two 3rds, and two 4<sup>ths</sup>.
